INTERGOVERNMENTAL AGREEMENT EXTENSION WITH THE TOWN OF FOUNTAIN  
HILLS AND CITY OF SCOTTSDALE FOR THE PROVISION OF ON-CALL EMERGENCY  
REPAIR SERVICES OF TRAFFIC SIGNAL FACILITIES**

THIS CONTRACT MODIFICATION made and entered into this 5<sup>th</sup> day of June, 2012, between the City of Scottsdale ("City"), and the Town of Fountain Hills ("Town"), both Arizona municipal corporations, amending the Contract dated June 28, 2011, between the City and the Town.

RECITALS:

The Mayor of the City of Scottsdale is authorized and empowered by provisions of the City Charter to execute Contracts and Contract Modifications; and

One (1) year under this Contract has been used with an option to extend for four additional one-year periods based on mutual agreement from both parties; and

The City desires to extend by one (1) year, the term of the original Contract No. 2011-066-COS for provision of on-call emergency repair services of traffic signal facilities with provision for additional routine preventative maintenance services, in accordance with the terms of the original contract; and

The City of Scottsdale and the Town of Fountain Hills mutually agree to extend and modify the Contract.

IN CONSIDERATION of the mutual promises and obligations of the Contract, the parties agree as follows:

1.0 EXTENSION:

In accordance with Article 7.0, *TERMS AND EXTENSION*, this contract is extended for an additional one (1) year period, commencing on the 5<sup>th</sup> day of June, 2012.

OTHER CONTRACT PROVISIONS:

All provisions of the original Contract not modified above shall remain in full force and effect as previously stated.






INTERGOVERNMENTAL AGREEMENT DETERMINATION
